### *For the Attention of the Occupant.*

Due to the increased incidence of crime in Barnet your councillors have agreed upon the restitution of a package of measures to combat a growing problem.

We have therefore determined to re-enforce *Bylaw No. 1014 – Section 106b* regarding property delineation within the Hampstead Garden Trust Estates.

#### ***This by-law states:***

***“.... and within the boundaries of the (Trust) estate all hedges, bushes and property delineations shall be maintained such that no growing matter exceed the height of 32” above the mean survey benchmarks for any property.”***

***“.... and furthermore with the exception of special trees noted on the Registrum Arborae dated 1921, no tree shall exceed the height of 32 feet above trunk base, nor display a bole width exceeding 8” as measured at 16” above the ground.”***

Due to the extensive works involved, the initial foliage reduction campaign will be undertaken by Barnet Streets Clean teams who will be operating in your area on April 12-15, 2005

At the same time that these operations are underway your council has also made provision for the supply and installation of panic button operated claxons along all dual hedge footpaths. The claxons will be fitted to 40' poles equipped with strobe lighting and include radio transmission to the local police station as well as CCTV to discourage unlawful use. These security enhancements will be located as currently marked out on your local dual hedged footpath and should be brought into full operation by the end of August, 2005.

Barnet Council welcomes all enquiries about our ongoing programmes to keep Barnet beautiful and safe.

This installation, coordinated in conjunction with the **Barnet Home Safe Campaign** and the **Royal Society for Protection of Birds** is also equipped to relay a video message back to operations centre to monitor the behaviours of occupants who are purportedly not watching television.

The **WatchBird** is designed to emit a regular birdcall at .7 second intervals to attract avian activity to your district.

If you have recently bought a licence, please contact us immediately so that we may redeploy this neighbourhood **WatchBird** elsewhere.

*Re: Application to Restore Chimney Stacks at 26 Wordsworth Walk, NW11 6AU*

The Trust's senior Architectural Advisor, Jane Blackman, has kindly forwarded details of your recent application to effect changes to your property within HGS Trust administered areas.

The Hampstead Garden Suburb Trust *Skyline Sub-committee* responsible for reviewing all applications for restorations of chimney features within the Suburb has reviewed your recent application and offers the following comments. We also kindly request additional clarification and information as outlined below.

- 1) Four chimney terminations are indicated on the drawings. Drawings and early photographs of the premises, including the one that you have kindly provided in the report, clearly indicate 5 terminations. Reduction in quantities will not be acceptable.
- 2) Your submission drawings indicate similar chimney terminations on adjacent buildings, being 22, 26 and 28 Wordsworth walk. Is it your intention to replace all of these chimney terminations with a similar termination? If you are proposing to spearhead a community renewal effort this should be made clear in the submitted documentation and consent forms provided which should be signed by each of the affected neighbours. Again we must note that the reduction in numbers from 5 to 4 terminations will not be acceptable.
- 3) The proposed chimney stack features appear from the drawings to be *Aeolian Crimps* with pronounced entasis. These have been scaled from the drawings at 762mm height. Entasis in chimney features is considered anachronistic detailing, more suited to a trans-atlantic market, and will not be acceptable. We are also not aware of manufacturing sources for *Aeolian Crimps*, if indeed they are, with this apparent dimension. Would your architect please clarify this issue.
- 4) As you are no doubt aware, uniformity of skyline terminations is not considered a virtue on the Suburb. The uniformity suggested by your 1970's photograph is undoubtedly another of the unfortunate effects of a World War. We would view more favourably an application proposing for instance 60% Doric Redonds, 20% Phrygian Fanals and 20% Crumpton Tiletops set out in a rhythm of A-A-B-A-C, although variations on this rhythm will be acceptable if a community wide initiative is proposed.

We are indeed fortunate to include on our advisory sub-committee Mr Horace Clitheroe *MBE* an acknowledged expert in chimney terminations and past director of the illustrious Rumsford Hearth Engineering Company. We would recommend that you get in touch with him by letter to the above address in order to develop a more sensitive and detailed scheme for your chimney restoration proposals. He will also be able to provide the appropriate forms if you are intending to spearhead a local community initiative.

Dear Ms McKenzie

I am writing to you to discuss the driver's licence which was recently issued to you. You attended a test at our Raydean House Driving Test Centre in Barnet on January 21<sup>st</sup>, 2010. This test was conducted by Mr Ivany Gorecki.

We regret to inform you that Mr Gorecki was unqualified to administer this driving test being himself unqualified with either driving licence or appropriate papers for residence in the United Kingdom. It is necessary for us to rescind your licence immediately.

In fact during the weeks that Mr Gorecki was employed by this driving centre he passed 384 drivers to 'on road status'. Many of these drivers were equipped with only the most rudimentary of driving or life skills and not a few cases of grievous road incompetence have been traced back to Mr Gorecki's negligence.

We do not for a moment presume that you are among the mentally challenged candidates that Mr Gorecki has indiscriminately approved. A certificate readily downloadable from the government website [www.directgov.uk/forms/psychstab-01](http://www.directgov.uk/forms/psychstab-01) and signed by your doctor or psychologist will suffice to reassure the centre when you next take the test.

The motives for Mr Gorecki's behaviour have not been adequately established and we have had to take the precaution of presenting your case together with those of the other suspect candidates to the Department of Terrestrial Security for investigation to ensure that there are no links between Mr Gorecki, yourself and known terrorist organisations.

We would kindly ask you to return you licence to my attention at the address noted below and refrain from driving your car even under a temporary permit until the situation has been regularised.

We will inform you of the outcome of our security clearance operations with DTS and contact you when you will be able to apply for a retaking of the practical exam.

Because such security clearance operations are extensive and may involve detailed interviews of all parties concerned we must apologise in advance for any delay in re-scheduling you test.

Designated Standpipe Oasis Centres will issue Ration Books to ensure fair distribution of basic free water supply, however additional vats may be purchased at the rate of £9.47 per 100 litres.

Oasis Centres will also distribute containers of reusable *Han-Dee Gel* suitable for dishwashing and laundry purposes. (£49.00 per 12 litre bottle + £95.00 bottle deposit) This product can be returned for refining with a return of bottle deposit.

#### **Further Conservation Provisions:**

1. During April your local council will be removing all large trees and other moisture dependant greenery identified in your area.
2. Sun scorched lawns result in further reduction of soil moisture and contribute significantly to further recession of ground water. Your local council will be making arrangements for all lawns to be reseeded with *gypsophila herculanis*.
3. Public parks and recreation areas and boulevards and will be seeded with a shading ground cover, (*euphorbia saharensis*) which has attractive spiky yellow umbrels. The waist height foliage provides deep ground shade to assist in conserving ground waters.

Due to the increasing demand for enhanced parking regulation throughout Barnet, your Council has consulted the Hampstead Garden Suburb Trust on effective ways to manage traffic flows throughout the suburb to create a comprehensive CPZ policy for the whole area.

The Trust informs us that effective legislation is already in place to deal with many of these problems. They have referred us specifically to *Bylaw No. 1072A – Section 106b* originally passed in 1933 to exclude tinkers, peripatetics and indigents.

***This by-law states:***

***“.... and within the boundaries of the (Trust) Estate all tinkers, peripatetics and indigents shall be summarily excluded unless they can demonstrate legitimate reason for passage.”***

Because of the permeable nature of access to Trust administered areas your Council proposes to close and regulate access and egress routes for vehicles and pedestrians to ensure that only those properly accredited can penetrate within Trust administered areas. Due to the extensive nature of works foreseen, your Council proposes to set up a single point of access to be located at the entrance of Hampstead Way off Finchley Road. Street width at this gateway is adequate to accommodate a substantial queue of vehicles.

Electronic guards will be equipped with Rapid-Scan iris recognition equipment to admit only registered persons and vehicles into the general exclusion zone. The RapidScan equipment can further benefit general enforcement criteria by being equipped to undertake ancillary tests simultaneously ensuring that vehicles comply with MOT requirements and are subject to no outstanding public order citations. It will be possible to impose on the spot fines upon non compliant vehicles or pedestrians.

Extending the ratepayers tax budgets, Barnet proudly boasts the most progressive outsourced infrastructure in the United Kingdom. Under an experimental pilot scheme the management of the new CPZ will be managed by Go-Get-M Ltd which is located in Mahabalipur in Madhya Pradesh. Helpline personnel will be on hand 24 hours a day to address citizens' complaints.

I am writing to inform you that following the recent Government directives the Principle Civil Service Pension Scheme will undergo further changes from April 1<sup>st</sup>, 2014.

Please disregard all previous advices.

The Classic Plus, Nuvos and Premium Schemes have all been discontinued and the contributions paid to date will be redesignated under our new rationalised programme initiative "*Common Sense for the Common Person*".

All future pension contributions from April 1<sup>st</sup>, 2014, will be deducted at source. These deductions can be estimated by factoring your Standard Pension Predisposition Quotient (SPPQ) into a Multiplicand of your date of birth, rendered as a six digit number and dividing the result by a standard deviation variable of 2.71, cross indexed with the CPI - base date of 1871.

Should you have any questions about these calculations or uncertainty about your assigned SPPQ, you should visit the Pensions Reform section of the Civil Service website ([www.civilservice.gov.uk/pensions/reform](http://www.civilservice.gov.uk/pensions/reform)) for the latest information on how reforms apply to you. Further information will be regularly posted on this website between now and April 1<sup>st</sup> 2015.

It has been brought to the attention of the Trust, as the result of your recent request for *Street Closure to Facilitate Delivery*, that you have ordered a Tiger Shed for erection in your front or rear garden at premises within the mandate of the Hampstead Garden Suburb Trust, without proceeding through appropriate clearance channels, and without reference to published '*Advices and Guidelines – A Helpful Guide to Those Intending to Erect an Ancillary Structure Within the Mandate of the Hampstead Garden Suburb Trust*'. Under *Section 24.12.12b* of the HGS Trust Charter, which is available at your local library, it is advised that '*development of all ancillary structures, amenity services and garden structures which involve the use of inter-fibrous friction fastening and preclude sunlight penetration to ground level*' **must** be submitted to the Trust for prior approval .

Though the Charter states that such permissions should not normally be withheld, we nevertheless deem it unlikely that your structure will be accorded unconditional approval. The proposed source, Tiger Sheds, is not on our list of approved shed suppliers. The provenance of materials, Norway, is not a member of the European Community and as such has no appropriate certification in place to ensure that all materials are IEES approved and are constructed with certified sustainable materials and workshop practices.

In addition to these concerns, I should note that the Trust tends to view unfavourably the keeping of wildlife on lands within our purview, in particular species that appear on any proscribed list under the *Convention on International Trade in Endangered Species (CITES)*.

We have notified all interested parties, in particular the World Wildlife Fund, of your intention to confront their informal guidelines with your proposed project. The WWF prefers to see this problem addressed in a natural habitat control rather than through direct citizen action at a local level.

We note that the size of the shed that you have ordered is insufficient to accommodate all but the most diminutive of *panther tigris* and that the Trust cannot offer crisis centres for rehousing such species when they have outgrown the structures that well-meaning citizens have laid on.

As many local residents will be aware, the lease on *Fellowship House* and *Bowling Green* will revert to Toynbee Hall in September of this year. The Head Lease on the *Mercury Tennis Club* will follow shortly after in January 2018.

The Board of Governors of Toynbee Hall has announced its intention to forgo a lease extension and to take direct control of these assets, bequeathed to them by Samuel Augustus Barnett in 1913. Under the terms of his will, the Hampstead Garden Suburb Trust has no jurisdiction over these specific properties. Toynbee Hall wish to create an exemplary shared ownership scheme for multi-racial families in duress. This will be a development with impeccable green credentials, that will be regarded as a landmark for progressive planning across London.

**Your Barnet!** welcomes the participation of world class 'starchitect', Renzo Piano, who has created ***The Green-a-Tat*** ©, a ***Radical Proposal for the Garden City of the 21<sup>st</sup> Century and Beyond***.



The architects have worked closely with the Hampstead Garden Suburb Horticultural Society, to define the character of the new community. The original Fellowship House, which succumbed to aerial bombardment in 1943, included a landmark tower of 27.34 metres height, positioned to command key views across Willifield Green. This historical landmark has established a precedent for the nine-storey massing envisioned by the architect.

***We want to hear from you!*** A Visitor Centre complete with detailed models explaining this zero carbon scheme will open in Fellowship House for public consultation on April 8<sup>th</sup>. During the construction period future benefit families will take up residence in an informal camp set up in Willifield Green.

We were disappointed that you were unable to attend our *Advice & Information Fayre* at Pardes House last week. It was a well-attended event and the presentations by Dementia UK and the Finchley Victoria Bowling and Cricket Club were particularly memorable.

It perhaps provided a comforting perspective upon recent events in Parliament. Over the past few tumultuous weeks it may seem to many that Parliament has lost its way amidst the complexities of party politics. Many will put the blame squarely on an egregiously self-serving Labour Party, its conflicted leadership, and aggressive Marxist policies. But I would also reluctantly admit that the Conservative Party must shoulder some of the responsibility for this confusion.

As you will be well aware I have always tried to spearhead the movement towards 'compassionate conservatism' which I believe to be the very essence of my mandate and a principal reason why Barnet has come back time and again to call upon a Conservative vision to lead the way into a changing world of the twenty first century.

**Wales Walrus Appeal 2021**

It is with growing excitement that we witness the reintroduction of *Odobenus rosmarus* to the coast of Pembrokeshire. This has been a great boost to those who have worked so tirelessly to reintroduce long suppressed native species to our landscape and help to rewild our coasts.

A healthy, full grown walrus will consume approximately 1000kg of fish and molluscs a day. Fortunately, an unforeseen benefit of the recent withdrawal from the European Community has been a large uptick in quantities of fish available for British consumption. It has been heartening to witness the massively positive response to our *British Fish for British Walruses* campaign.

However, this cannot be regarded as a permanent solution and our scientists are looking into sustainable alternatives to supplement the walrus diet and ensure that they continue to make their homes on British beaches.

We are researching cruelty free alternatives to provide a burgeoning walrus community with longer-term sustenance.
